Report of the Trustees for the Year Ended 31 March 2021

The trustees present their report with the financial statements of the charity for the year ended 31 March 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS I 02) (effective I January 2015).

OBJECTIVES AND ACTIVITIES

Charitable Purposes

The organisation's purpose is to provide people of all ages, backgrounds and abilities with the opportunity to ride or be around horses to benefit their health and wellbeing in the Helensburgh and Lochside, Dumbarton, Vale of Leven, Clydebank and surrounding areas.

RDA gives people the chance to:

Reach therapeutic goals: improve muscle tone and posture, develop motor skills.

Achieve their personal ambitions: whether this is to sit on a horse for the first time, learn new skills, or take part in competitions at local, regional or national level.

Combat social isolation: build relationships, enjoy events and competition, develop self-confidence.

Develop life skills: improve communication, take responsibility, be a team player.

Experience the outdoors: ride in the countryside, access rural Britain.

Connect with animals: adding a new element to life.

Activities

We cater for adults, young people and children with a wide range of conditions. Our hoist and lift enable some wheelchair users, those with limited physical ability, and heavier riders to mount and dismount. Gareloch run nine group riding sessions plus an additional three private or semi-private sessions per week. In addition, there are currently two individual horse care sessions per week. Riders attend either weekly or fortnightly, generally in line with the school terms.

ACHIEVEMENT AND PERFORMANCE Charitable activities

I had not expected to have to say this, but a warm welcome to our Second Zoom AGM. If nothing else, this last year has taught us not to make assumptions and to be flexible!

As mentioned in my last report, with only the very limited possibility of being able to offer any riding, and therefore getting any income, we had decided to move all but Harris away off the yard to grazing. I am extremely grateful to the owners and staff at Easterton, the owners and staff at Ardencaple and to Vikki Allan for supporting us in looking after our various equines while they were away from Colgrain.

Joan's Carers Ltd. very generously sponsored the livery costs of Bobbie through the winter months and another unnamed donor sponsored Isaac. Both the boys thoroughly enjoyed their time up on the hill and I know that the team (Elise, Mary, Trish, Moira, Amy, Catherine, Joy, Dom and Andrea) from Gareloch, who looked after the horses on a daily basis, really enjoyed the support and welcome they received. Thank you everyone.

Bella and Hettie returned to Colgrain in September. Riding sessions tentatively restarted at the end of September 2020 with Harris and Bella. Sadly, after just a few sessions it was clear that Bella was no longer happy to continue her RDA sessions. We are very pleased that one of our experienced volunteers has taken her on trial as a family pony. We are most grateful to Glasgow RDA for the loan of their pony Oli to take Bella's place. Oli is an old hand at RDA and stepped right up to the mark. By the end of December 2020, we had, despite the Covid restrictions, been able to grow back up to 13 riders per week, over Monday and Friday afternoons. Then we went back into lockdown. Riding restarted again on Monday 5th April with our same 13. We are ready to build that up to 17 in the next week or two. The schools have only just received their guidance as to what they will or will not be able to do so we anticipate it will be a little time before Parklands can consider restarting at which point we will have to reorganise ourselves again. I am very proud of how much we have been able to achieve so far but we still have over 40 riders on our books who are waiting to return whenever that will be possible.

Harley has remained at Easterton on part loan to one of our riders. We are working towards her upkeep being fully funded. Hettie has gone on loan to Easterton Riding School as a lead rein pony. She rules the field of little ponies, is very well, happy and much loved. She will stay there until our future programme is in place. Brodie is on part loan and part funded at Colgrain. He also does a few RDA sessions per week.

The Carriage Driving boys returned to Colgrain on 19th April to begin preparation for resumption of RDA Carriage Driving in Scotland. The provisional date for which is 15th May (?). We are still waiting for Isaac to pass his RDA Assessment but we anticipate that he will be thrilled to get back to work again and it won't take long. Patsy Muir Simpson (Carriage Driving Rep.) is prepared to come and assess him as soon as he is ready.

In order to expand our activities but without the possibility of providing more riding, we have applied for and been registered as an RDA Group providing 'Tea with a Pony'. This has been in discussion for some time, but we are now that much nearer to being able to offer this opportunity to those living with dementia or other life impacting conditions to spend happy, comforting, and fun time with ponies. This is an exciting and most welcome step forward.

Over this last year managing our finances has been 'testing'. The ponies being away eased our monthly financial costs enormously but now with five back on full livery it will be a greater challenge. We are extremely grateful to the many individuals and organisations who have continued to give us funding and donations including RDA volunteers who are currently unable to volunteer, RDA National Office, Children in Need, MEB Foundation, SIM Property Management, Urquhart Knox Redmayne, Heron Construction LTD, and again our friends, Buddies in Boats. We are looking at ways in which we can ensure regular income from lessons and exploring ever wider sources of funding to cover our growing costs. Thanks to Julia Barr, our Fundraising Trustee, for all that she has achieved in this very complex year. There is no doubt that Fundraising is a specialist role, Julia does a great job, but she is keen to have some assistance given that she also has a fulltime career and two small children. If anyone is interested, please get in touch with Julia or a trustee.

I would like to forward my personal thanks to the volunteers who have continued to work with the ponies throughout the last year and a quarter, keeping them safe, well and motivated. This time has created unexpected space for training and learning but it has been very demanding on this small band of people.

A huge thank you to our team of young volunteers who have made themselves available to help in sessions, clean tack, exercise our ponies. Always smiling, under their PPE, and always willing to do whatever is required. We could not manage without you.

Our limited number of coaches remain a problem. Fiona has stepped down as lead coach to focus on her own duties running Colgrain but she remains a coach and will be ready for her RDA riders return. I am pleased to say that we currently have four coaches in training but we need more.

During the last year we have set up a Gareloch SLACK Group. This enables us to share information on any pertinent subject with individuals or groups of people. Our hope is that this will enable everyone to be part of the everyday running of our RDA Group. If you are not a member and you should like to be please contact one of the Trustees.

Thanks to the Spy family for welcoming us back to Colgrain and to Vikki for her continued horse management.

Finally, I wish to acknowledge the efforts of the Board of Trustees over the last year. Due to the pandemic and ongoing issues there has been a much greater requirement for regular communication, but we have risen to the challenge and become experts in Zoom! Each committee member has gone well above and beyond. Thank you. Special thanks go to Mary Jardine, who is retiring as our Safeguarding Officer this year. Annemarie Webster will be putting herself up for election at the AGM

FINANCIAL REVIEW Reserves policy

The Trustee's policy is to attempt to retain a year's worth of normal running costs. In addition, due to the growing expense of horse insurance and the vagaries of the cover provided, the Trustees have put aside £25,462 to cover any unexpected expenditure on veterinary costs. Whilst this may seem a large amount for a charity, should any one of our horses need extensive veterinary treatment this could cost many thousands of pounds. We must ensure that we have sufficient funds to take care of all of our horses. To cover both future trading costs and veterinary costs we hold £46,026 on deposit.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Constitution

The Charity is a Scottish Charitable Incorporated Organisation, registered in its current legal form in March 2012. It has a two-tier structure where the Membership of the group appoint the trustees and have decision making powers. The Management Committee is responsible for the day to day running of the group.

Appointment of trustees

The management Committee consists of the charity's trustees. Membership of the Management Committee is open to all volunteers, participants and supporters of the Group. Trustees are elected at the Annual General Meeting which is held within fifteen months of the date of the previous Annual General Meeting. There must be a minimum of three and a maximum of eleven trustees.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective I January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received, and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on a receipts and payments basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings, they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
